#### Sir,

I am directed to refer to the approval of the competent authority to release an amount of Rs. 67,40,35,000/- (Rupees Sixty Seven Crore Forty Lakh and Thirty Five Thousand Only) as 2nd Installment of Enhancing Quality and Excellence in select autonomous colleges to 3 Colleges, 2nd Installment of Infrastructure Grants to 4 Colleges, 3rd Installment of Infrastructure Grants to 1 College, 2nd Installment of Infrastructure Grants to 79 Colleges, 2nd Installment of Infrastructure Grants to 8 Colleges, 3rd Installment of Infrastructure Grants to 2 Universities, Next installment of MMER, 1st Installment of New Model Degree College to 1 College, 1st Installment of Preparatory Grant, 2nd Installment of Research, Innovation & Quality Improvement- Entrepreneurship & Career Hub to 2 Universities, 1st Installment of Research, Innovation & Quality Improvement- Major Research Projects to 2 Universities. The central: state share of 60:40 to be incurred to the State Government of Kerala under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the quidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide D.O.No.32/PSO/FS/2015 Dated 28th October, 2015 for General Category States, the funding pattern is revised to 60:40. Kerala comes under the General Category State. The 2nd Installment of Enhancing Quality and Excellence in select autonomous colleges to 3 Colleges, 2nd Installment of Infrastructure Grants to 4 Colleges, 3rd Installment of Infrastructure Grants to 1 College, 2nd Installment of Infrastructure Grants to 8 Colleges, 3rd Installment of Infrastructure Grants to 2 Universities, Next installment of MMER, 1st Installment of Infrastructure Grants to 2 College to 1 College, 1st Installment of Preparatory Grants for Model Degree.



Research, Innovation & Quality Improvement- Entrepreneurship & Career Hub to 2 Universities, 1st Installment of Research, Innovation & Quality Improvement- Major Research Projects to 2 Universities. The central : state share of 60:40 to be incurred to the State Government of Kerala under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to Rs. 67,40,35,000/- (Rupees Sixty Seven Crore Forty Lakh and Thirty Five Thousand Only). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme. As certified by the State:

- The State has implemented the SNA System. i.
- The fund released would be transferred to SNA as per the relevant ii. instructions and within the stipulated timeframe.
- iii. The funds released during previous financial years have been transferred to SNA Account.
- SNA and IAs have been mapped on PFMS Portal. iv.
- Interest earned has been deposited into CFI. V.
- vi. The balance is SNA Account is less than the amount being released.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts to the RUSA bank account of State Higher Education Council (SHEC).

5. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of Kerala. Further, the accounts of Kerala SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

6. The amount shall be debited to the following three Heads of Demand No.25-Department of Higher Education:

9. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.
